INTERNATIONAL OPERATING CHARTER FOR The Independent Nation known as ANPC INTERNATIONAL

(Hereinafter referred to as "ANPC" which shall mean the ANPC International nation)

The ANPC International Independent nation, hereby creates this charter for the purpose of international recognition of the ANPC International nation and its members, said charter being subject to ratification by majority vote of the governing nation council. Now, therefore, We, by virtue of the authority conferred upon us by the Divine Creator, do hereby approve this Charter, to be effective from and after such time as it may be ratified by a majority show of hands by the governing nation council of ANPC INTERNATIONAL; Provided however, that such election shall be void unless the total conclusion reached be at least 70 percent of said governing nation council.

Wherefore we come, through establishment of the ANPC INTERNATIONAL TRUST, being organized as a private members association comprised of members of many cultures, religions, nations, indigenous and native tribes whose inhabitation is spread internationally across all of these Lands known as planet earth which also includes but is NOT LIMITED TO Turtle Island / The North America Gate / America commercially and politically known as the United States as well as other lands on planet earth where said members may dwell.

Through this Charter ANPC International hereby secures our nation and members rights;

- a) To have the ability, by its organized departments, to serve all necessary functions and to engage in business as needed;
- b) To protect and defend in any court; Provided, however, that the grant or exercise of such power shall not be deemed a consent by ANPC to the levy of any judgment, lien, or attachment upon any property of ANPC INTERNATIONAL, other than specific funds or chattels especially pledged or assigned as such;

- c) To make and use a nation seal and flag and alter them when desired to do so;
- d) To appoint such representatives or ambassadors as the nation of ANPC may require, and to allow them suitable compensation where appropriate;
- *e)* To enter into any obligations or contracts essential to the transaction of its ordinary affairs or for the business purposes and activities as above set forth;
- *f)* To borrow money from lenders of choice or from any agency, from any member or association of members of ANPC INTERNATIONAL, or from any other source, and to accept donations in any amount to fund humanitarian projects.
- g) To create and house our own private financial institutions and vaults or to deposit trust funds in any bank or financial institution of choice, and to hold our own Private Insurance Pool for liability coverage of our members;
- h) To negotiate with the international, federal, state, tribal or local governments or corporations, and to advise or confer with the representatives of any such governments or corporations including but not limited to the United States on matters which may affect the functioning of ANPC or any of its members thereof;
- *i)* To employ private counsel for the protection and advancement of the rights of ANPC and its members and to fully defend said rights;
- *j)* To prevent any disposition, lease, encumbrance or confiscation of any property, land, or assets of ANPC INTERNATIONAL, or any members thereof, including but not limited to ANPC private car tags, foreign drivers licenses and international driving permits as well as any conveyances registered to ANPC INTERNATIONAL, ANTA by any member thereof; and to prevent involuntary servitude (slavery) by forced assimilation of adhesion contracts, i.e. state driver's license, state car tags, social security numbers and any/all corporate rules which are in violation of article 4 of the Universal Declaration of Human Rights;
- *k)* To make assignments of land, property or assets or instruments belonging to ANPC and its members thereof, and to regulate the use and disposition of such assignments;
- *l)* To appropriate trust funds for expenses of administering the affairs of the nation and for any other purposes of benefit to ANPC INTERNATIONAL;
- *m*) To regulate the manner of holding ANPC elections;
- *n)* To regulate the procedure and appointment of the representatives and membership and all other ANPC committees;

- o) To protect and preserve the private/real property, natural resources, crafts, culture, and traditions of the living men and woman of any or all indigenous tribes, nations and cultures which are represented by ANPC INTERNATIONAL;
- p) To hold accountable any member of ANPC for violation of the ANPC constitution or guidelines, not exceeding in any case fifty .99 minted 1-ounce Troy Silver pre-1933 or any internationally equivalent recognized currency for any one offense, or in the alternative, expulsion from ANPC or suspension of certain rights therein;
- *q)* To purchase, take by gift, bequest, or otherwise own, hold, manage and dispose of property of every description, real, personal or private;
- r) To issue bonds, negotiable instruments of exchange, written agreements or other nation assets or interests in trust property in exchange for real or personal properties held in reserve by ANPC and its members;
- s) To protect any interest, which belongs to ANPC INTERNATIONAL, or that its men and women may have naturally, and protect any established agreements made by the members as named in section (r) above;
- t) To delegate to subordinate entities, committees, or representatives, or to any cooperative association which is open to all members of ANPC INTERNATIONAL, any of the foregoing powers, reserving the rights to review any actions taken by virtue of such delegated powers;
- *u)* To create and issue our own private nation documents including but not limited to private car tags and registration, international drivers' licenses, international driving permits, identity cards, passports, private bonds, trusts, marriage covenants and private birth records;
- *v)* To update federal land patents and registering into trust the lands of the ANPC Members;
- w) To exercise such further powers as many in the future be delegated to the ANPC nation council;
- x) To have and hold lawful money of exchange (Gold and Silver), to also use money of accounts i.e. commercial paper such as (IBOE, BOE, BONDS, PROMISSARY NOTES, NEGOTIABLE INSTRUMENTS) and other methods of discharge that are available under UCC 3-603 (b) and HJR 192, Public Law 3-10 etc;
- *y)* ANPC is a peaceful sovereign nation, and shall not in any way be viewed as an enemy combatant of the state or any state in which the nation may operate.

LIMITATION OF THE FOREGOING CHARTER POWERS SHALL BE SUBJECT TO THE FOLLOWING:

- 1. No land, property or assets belonging to ANPC or interest in such shall be sold or mortgaged unless by majority vote of ANPC nation council.
- 2. No land, property or assets or interest in such owned by ANPC shall be leased for a longer period than ten years, except that oil, gas, or mineral leases may be for longer periods when authorized by majority nation council vote only.
- 3. Any lease, grazing permit, or timber sale contract covering land owned by ANPC shall provide that the man or woman to whom such lease, permit, or contract is awarded, must confer with international regulations under Universal Declaration of Human Rights and laws governed by the United Nations.

II.

CHARTER RIGHTS AND PROPERTY

No right or power heretofore vested in ANPC INTERNATIONAL, not expressly referred to in the ANPC Constitution, Bylaws, agreements, or Charter, shall be abridged, but may be exercised by the members upon approval of the nation council through the adoption of appropriate additions and amendments to the Constitution, Bylaws, agreements or Charter of ANPC INTERNATIONAL. No property rights or claims of ANPC existing prior to the ratification of the Charter shall be in anyway impaired by anything contained in this Charter. The individually owned private property of members of ANPC shall not be subject to any corporate debts or liabilities, without such owners' consent.

III.

RATIFICATION

This Charter shall be effective from and after the date of its ratification by a majority vote of the nation council of ANPC INTERNATIONAL , provided at least 70 percent of the authorized nation council shall vote, and provided further that ANPC has agreed to create Bylaws and adopt the ANPC Constitution until the nation council ordain and establishes another written ANPC Constitution approved by the nation council of ANPC INTERNATIONAL .

The ratification of the Charter shall be formally certified by at least 70 percent of the nation council of ANPC INTERNATIONAL.

INTERNATIONAL TREATY FOR The Independent Nation known as ANPC INTERNATIONAL

(Hereinafter referred to as "ANPC" which shall mean the ANPC International nation)

The people of the ANPC International independent nation, hereby create this treaty for the purpose of establishing the unalienable rights endowed by the Creator on each member, said treaty being subject to ratification by majority vote of the members council. Now, therefore, We, by virtue of the authority conferred upon us by the Divine Creator, do hereby approve this Treaty, to be effective from and after such time as it may be ratified by a majority show of hands by the members council of ANPC INTERNATIONAL; Provided however, that such election shall be void unless the total conclusion reached be at least 70 percent of said governing nation council.

Key Treaty Provisions

Note: ANPC International support and are supported by Natural Law which was used to establish this International Peace Treaty, the International Charter as well as our adopted Universal Declaration of Human Rights, Constitution, and Rules of Conduct. Natural law, which is the unalienable rights endowed by the Creator, establishing that certain rights or values are inherent in or universally recognized by virtue of human reason or human nature, Influenced also by the universal law of "natural right", the rights of man are held to be universal and perpetually valid, pertaining to human nature itself. It is the basis for a nation of free-living men and woman protected equally by law.

These declarations are in the spirit of "secular natural law", which does not base itself on religious doctrine or authority, in contrast with traditional Natural law, and has collective rights for all people. By the universal law of Natural rights, these rights are held to be universal and perpetually valid. The members of ANPC have unalienable Natural rights to property, to liberty, happiness and to life. According to Natural Law, the role of government is to recognize and secure these

rights. "The natural and imprescriptible rights of man" are defined as "liberty, property, security and resistance to oppression".

Through this Treaty, the members of ANPC International hereby secure our unalienable God given rights;

- 1. To protect the unalienable Universal Human Rights, under Natural law, of the members of ANPC;
- 2. To assert the ANPC member's Creator endowed rights, under Natural law, to travel freely and peacefully across the land and to cross international, national, and state borders without interference;
- 3. Under natural law and rights, to be recognized each as an independent self-governing Nation throughout all lands and to restore life, liberty and freedom to all;
- 4. Protecting all private properties under Natural laws and rights of ANPC members by affirming that as living men and women our Creator endowed natural laws are prior and paramount;
- 5. Respecting, restoring, restructuring and honoring all lands, air, agriculture and waters from the environmental destruction resulting from dishonor of our earth through exercising our rights of political representation before all national and international bodies.
- 6. Engaging in mutually beneficial trade and business between global nations and any economic enterprises owned "collectively" by the members of our ANPC nation to promote such business without interference by other governments.

PRINCIPLES

The members of ANPC hereby subscribe to the following principles:

- 1. The Creator has made us part of, and, inseparable from the Natural law and world around us. The truth binds us together and gives rise to the shared commitment to care for, conserve, and protect the land, air, water, plant, and animal life upon our beloved planet;
- 2. Under Universal Natural Law, we retain our inherent Creator Endowed rights to self-governance and self-determination which have existed since time immemorial, having been bestowed on us by our Creator and defined in accordance with our own Natural laws, values, customs and morals;
- 3. We declare that all political, social, cultural and economic relationships between all Nations have existed since time immemorial, and we declare our right to continue such relationships. This natural right is inseparable from our inherent natural rights of nationhood.

ANPC members have the right of self-determination and, by virtue of that right, may freely determine our political status and pursue our social, cultural and economic development without recourse;

- 4. No other political jurisdiction, including nations, countries, states or counties and their governmental agencies, departments, corporations or subdivisions, possess governmental power over any ANPC member, their bodies, private properties, (posterity, conveyances etc.), or the nation of ANPC. If any issue regarding a member arises, any outside government shall contact the ANPC Nation Government by written affidavit of fact concerning the disturbance;
- 5. Our inherent, original control and enjoyment of our lands and territories includes our collective rights over the environment consisting of the air, agriculture, lands, inland waters, oceans, seas, sea ice, flora, fauna and all other surface and sub-surface resources.
- 6. Our inherent natural rights include all traditional and ecological knowledge derived from our relationship with our lands, air and waters from time immemorial, the exercise of conservation practices, traditional ceremonies, medicinal and healing practices and all other expressions of art and culture;

During our Treaty deliberations the ANPC members council agreed:

- 1.) The Treaty will unify our voice, identify the impacts of climate change on our traditional private lands and seek independent representation of these concerns before international bodies.
- 2.) The Treaty will serve as a political alliance to assert the primacy of Natural and moral law regarding the definition of rights to the private properties, sacred objects and traditional knowledge base of each global nation.
- 3.) The Treaty creates a structure to facilitate and regulate international and inter-indigenous nation trade and business, an economic alliance for mutual support and benefit in the pursuit of global nations self-sufficiency and sustainability.
- 4.) The Treaty will unify the efforts of nations regarding border-crossing rights and in the protection of Universal Declaration of Human Rights.

OUR GOALS:

1. To establish supportive bonds among global Nations in order to secure, recover and promote, through political, cultural and economic unity, the Creator endowed rights of all ANPC Members and for the well-being of all future generations.

- 2. To establish a foundation for the exercise of ANPC member's national inherent rights, without regard to existing or future international political boundaries of global nations, for the following purposes:
- (a) Protecting our own Natural and inherent laws, rights and customs regarding our private properties are prior and paramount to the assertion of any other laws or jurisdictions including international bodies and agencies hereto, herein, and hereafter;
- (b) Engaging in mutually beneficial trade and business between nations and the economic enterprises owned and operated collectively by ANPC members and by those of other global nations;
- (c) Preserving and protecting the Universal Human Rights of our ANPC Members from such violations as involuntary servitude (a form of slavery) by any/all forced assimilation contracts; (i.e. forced taxation, state driver's licenses, state car tags, state marriage licenses, state birth certificates, social security numbers, forced vaccination etc.), human trafficking, confiscation of private property (lands, time and energy, posterity, private conveyances etc.), or any other forms of oppression.
- 3. To develop an effective and meaningful process to promote communication and cooperation among all global Nations on all other common issues, concerns, pursuits and initiatives.

MUTUAL COVENANTS

We, the nation council for ANPC, reserving all our natural rights as endowed by our Creator, hereby do approve of the attached International Treaty for ANPC and are committed to providing the following mutual aid and assistance, to the best of our ability and in accordance with our own prior and paramount Natural laws, customs and traditions:

- 1. Exchanging economic, legal, political, traditional and technical knowledge regarding the protection of ANPC Members and their intellectual properties.
- 2. Collaborating on research on environmental issues that impact our homelands, including baseline studies and socio-economic assessments that consider the cultural, social and sustainable uses of agricultural lands and resources and offering solutions for clean energy.
- 3. Participating in trade and business missions to lay a foundation for business relations and the development of an international, integrated global economy.

UNIVERSAL DECLARATION OF HUMAN RIGHTS

Adopted by the ANPC International Independent Nation

The people of the ANPC International independent nation, hereby adopt this declaration for the purpose of reinforcing the unalienable rights endowed by the Creator on each member by life.

PREAMBLE

Whereas recognition of the inherent dignity and of the equal and inalienable rights of all members of the human family is the foundation of freedom, justice and peace in the world,

Whereas disregard and contempt for human rights have resulted in barbarous acts which have outraged the conscience of mankind, and the advent of a world in which human beings shall enjoy freedom of speech and belief and freedom from fear and want has been proclaimed as the highest aspiration of the common people,

Whereas it is essential, if man is not to be compelled to have recourse, as a last resort, to rebellion against tyranny and oppression, that human rights should be protected by the rule of law,

Whereas it is essential to promote the development of friendly relations between nations,

Whereas the peoples of the United Nations have in the Charter reaffirmed their faith in fundamental human rights, in the dignity and worth of the human person and in the equal rights of men and women and have determined to promote social progress and better standards of life in larger freedom,

Whereas Member States have pledged themselves to achieve, in co-operation with the United Nations, the promotion of universal respect for and observance of human rights and fundamental freedoms.

Whereas a common understanding of these rights and freedoms is of the greatest importance for the full realization of this pledge,

Now, Therefore THE GENERAL ASSEMBLY proclaims THIS UNIVERSAL DECLARATION OF HUMAN RIGHTS as a common standard of achievement for all peoples and all nations, to the end that every individual and every organ of society, keeping this Declaration constantly in mind, shall strive by teaching and education to promote respect for these rights and freedoms and by progressive measures, national and international, to secure their universal and effective recognition and observance, both among the peoples of Member States themselves and among the peoples of territories under their jurisdiction.

Article 1.

All human beings are born free and equal in dignity and rights. They are endowed
with reason and conscience and should act towards one another in a spirit of
brotherhood.

Article 2.

Everyone is entitled to all the rights and freedoms set forth in this Declaration, without distinction of any kind, such as race, colour, sex, language, religion, political or other opinion, national or social origin, property, birth or other status.
 Furthermore, no distinction shall be made on the basis of the political, jurisdictional or international status of the country or territory to which a person belongs, whether it be independent, trust, non-self-governing or under any other limitation of sovereignty.

Article 3.

Everyone has the right to life, liberty and security of person.

Article 4.

• No one shall be held in slavery or servitude; slavery and the slave trade shall be prohibited in all their forms.

Article 5.

 No one shall be subjected to torture or to cruel, inhuman or degrading treatment or punishment.

Article 6.

• Everyone has the right to recognition everywhere as a person before the law.

Article 7.

All are equal before the law and are entitled without any discrimination to equal
protection of the law. All are entitled to equal protection against any discrimination
in violation of this Declaration and against any incitement to such discrimination.

Article 8.

• Everyone has the right to an effective remedy by the competent national tribunals for acts violating the fundamental rights granted him by the constitution or by law.

Article 9.

No one shall be subjected to arbitrary arrest, detention or exile.

Article 10.

• Everyone is entitled in full equality to a fair and public hearing by an independent and impartial tribunal, in the determination of his rights and obligations and of any criminal charge against him.

Article 11.

- (1) Everyone charged with a penal offence has the right to be presumed innocent until proved guilty according to law in a public trial at which he has had all the guarantees necessary for his defence.
- (2) No one shall be held guilty of any penal offence on account of any act or omission which did not constitute a penal offence, under national or international law, at the time when it was committed. Nor shall a heavier penalty be imposed than the one that was applicable at the time the penal offence was committed.

Article 12.

 No one shall be subjected to arbitrary interference with his privacy, family, home or correspondence, nor to attacks upon his honour and reputation. Everyone has the right to the protection of the law against such interference or attacks.

Article 13.

- (1) Everyone has the right to freedom of movement and residence within the borders of each state.
- (2) Everyone has the right to leave any country, including his own, and to return to his country.

Article 14.

- (1) Everyone has the right to seek and to enjoy in other countries asylum from persecution.
- (2) This right may not be invoked in the case of prosecutions genuinely arising from non-political crimes or from acts contrary to the purposes and principles of the United Nations.

Article 15.

- (1) Everyone has the right to a nationality.
- (2) No one shall be arbitrarily deprived of his nationality nor denied the right to change his nationality.

Article 16.

- (1) Men and women of full age, without any limitation due to race, nationality or religion, have the right to marry and to found a family. They are entitled to equal rights as to marriage, during marriage and at its dissolution.
- (2) Marriage shall be entered into only with the free and full consent of the intending spouses.
- (3) The family is the natural and fundamental group unit of society and is entitled to protection by society and the State.

Article 17.

- (1) Everyone has the right to own property alone as well as in association with others.
- (2) No one shall be arbitrarily deprived of his property.

Article 18.

Everyone has the right to freedom of thought, conscience and religion; this right
includes freedom to change his religion or belief, and freedom, either alone or in
community with others and in public or private, to manifest his religion or belief in
teaching, practice, worship and observance.

Article 19.

- Everyone has the right to freedom of opinion and expression; this right includes freedom to hold opinions without interference and to seek, receive and impart information and ideas through any media and regardless of frontiers. **Article 20.**
- (1) Everyone has the right to freedom of peaceful assembly and association.
- (2) No one may be compelled to belong to an association.

Article 21.

- (1) Everyone has the right to take part in the government of his country, directly or through freely chosen representatives.
- (2) Everyone has the right of equal access to public service in his country.
- (3) The will of the people shall be the basis of the authority of government; this will shall be expressed in periodic and genuine elections which shall be by universal and equal suffrage and shall be held by secret vote or by equivalent free voting procedures.

Article 22.

• Everyone, as a member of society, has the right to social security and is entitled to realization, through national effort and international co-operation and in accordance with the organization and resources of each State, of the economic, social and

cultural rights indispensable for his dignity and the free development of his personality.

Article 23.

- (1) Everyone has the right to work, to free choice of employment, to just and favourable conditions of work and to protection against unemployment.
- (2) Everyone, without any discrimination, has the right to equal pay for equal work.
- (3) Everyone who works has the right to just and favourable remuneration ensuring for himself and his family an existence worthy of human dignity, and supplemented, if necessary, by other means of social protection.
- (4) Everyone has the right to form and to join trade unions for the protection of his interests.

Article 24.

 Everyone has the right to rest and leisure, including reasonable limitation of working hours and periodic holidays with pay.

Article 25.

- (1) Everyone has the right to a standard of living adequate for the health and wellbeing of himself and of his family, including food, clothing, housing and medical care and necessary social services, and the right to security in the event of unemployment, sickness, disability, widowhood, old age or other lack of livelihood in circumstances beyond his control.
- (2) Motherhood and childhood are entitled to special care and assistance. All children, whether born in or out of wedlock, shall enjoy the same social protection.

Article 26.

- (1) Everyone has the right to education. Education shall be free, at least in the elementary and fundamental stages. Elementary education shall be compulsory. Technical and professional education shall be made generally available and higher education shall be equally accessible to all on the basis of merit.
- (2) Education shall be directed to the full development of the human personality and to the strengthening of respect for human rights and fundamental freedoms. It shall promote understanding, tolerance and friendship among all nations, racial or religious groups, and shall further the activities of the United Nations for the maintenance of peace.
- (3) Parents have a prior right to choose the kind of education that shall be given to their children.

Article 27.

- (1) Everyone has the right freely to participate in the cultural life of the community, to enjoy the arts and to share in scientific advancement and its benefits.
- (2) Everyone has the right to the protection of the moral and material interests resulting from any scientific, literary or artistic production of which he is the author.

Article 28.

• Everyone is entitled to a social and international order in which the rights and freedoms set forth in this Declaration can be fully realized.

Article 29.

- (1) Everyone has duties to the community in which alone the free and full development of his personality is possible.
- (2) In the exercise of his rights and freedoms, everyone shall be subject only to such limitations as are determined by law solely for the purpose of securing due recognition and respect for the rights and freedoms of others and of meeting the just requirements of morality, public order and the general welfare in a democratic society.
- (3) These rights and freedoms may in no case be exercised contrary to the purposes and principles of the United Nations.

Article 30.

• Nothing in this Declaration may be interpreted as implying for any State, group or person any right to engage in any activity or to perform any act aimed at the destruction of any of the rights and freedoms set forth herein.

CONSTITUTION FOR The Sovereign Nation known as ANPC INTERNATIONAL

(Hereinafter referred to as "ANPC" which shall mean the ANPC International nation)

The Preamble to the Constitution

Whereas independence is the inherent Creator endowed right of all nations and confinity with humanity and justice is for highest good; the moment of rejoicing has come and is heard in the voices of the ANPC International or "ANPC" to be free, independent, united, just and prosperous; By the grace of the Divine Creator under Natural Law, we have been motivated by the noble desire to live a peaceful, free life and now the people of ANPC International hereby joyfully declare their independence.

Subsequent thereto, to form a free nation which shall protect all the independence of the people of ANPC, promote Peace, and to establish a world based on freedom, perpetual peace, social justice, and Creator endowed rights, therefore the independence of ANPC International shall be formulated into a constitution for ANPC which shall be built into a free nation based on a belief in the divine Creator, just and civilized humanity, the peace and unity of global Nations, and a peaceful life led by wisdom of thoughts in deliberation amongst representatives of the people, and achieving justice for all the members of ANPC.

CHAPTER 1 Inherent Rights of ANPC Members

The International Universal Declaration of Human Rights has been adopted by the ANPC International and shall be further referenced in regards to all inherent rights of the ANPC members.

- 1. Every ANPC member has the inherent right to live in physical and spiritual prosperity, to have a home and to enjoy a peaceful and healthy environment, collecting natural resources from the earth including water, air and food without restriction, permission or recourse.
- A). Every ANPC member has the inherent right to lawfully safeguard their lands and home from unlawful taxation and evictions by any lawful means including de-registering property and updating land patents including mineral rights.

- 2. Every ANPC member has the inherent right to choose beneficial care for health and well-being as well as take accountability for their own and their family's health through natural non-invasive healing practices, including but not limited to, homebirth, natural therapies etc.
- A.) Every ANPC member has the inherent right to accept or refuse any and all types of western medical interventions including vaccinations and forced medication. This inherent right shall be respected globally at all times nor shall it hinder, challenge or infringe upon any man, woman or child's right to education, travel, communication etc. without recourse to themselves or their families.
- B.) Every ANPC member has the inherent right to choose for themselves and their posterity, non-invasive healing methods in lieu of invasive treatments i.e. chemotherapy, radiation or any other treatment they shall choose or choose not to accept without recourse to themselves or their families.
- C.) Furthermore, ANPC members have the inherent right to their choice of life or death and their choice of a green burial including an unregistered private will that shall be honored with freedom from any regulations or repercussion to themselves or their families.
- D.) Furthermore ANPC members have the inherent right to choose where their posterity shall be born and brought forth on the land and shall have full authority to accept or reject any/all contracts, i.e. state issued certificates of live birth, the right to full disclosure of any and all contracts, and the right to choose family Bible or private Live born records or other traditional family recording methods without recourse to themselves or their families.
- E.) Furthermore, ANPC members have the inherent right under Natural Law to be protected from any inference and/or unlawful actions that cause injury, harm or disruptions to the family security by any departments, agencies or corporations in the lives of their young or families, and to hold self-insurance against any such interference.
- 3. To grow their own organic gardens for food and herbs without any infringement or restrictions of said rights and to protect the ground soil from toxic interferences of any kind etc.
- 4. To clean air, pure water and fertile soil in all that surrounds them.
- 5. To detoxify and clean any and all non-beneficial substances that are in their air, water or soil that are not conducive to individual, plant, animal, aquatic and all other beneficial life forms and their well-being. The living men and woman of ANPC honor the five elements of nature, the Laws of Nature and Nature's God.
- 6. To protect their strict privacy whether it be through satellite, electronic devices, electronic communications, phone communications, or any other business, home or ionospheric global programs and to Privately create and maintain any and all forms of the above listed communications public or private.

- 7. Impoverished men and women, including elderly, disabled or special needs as well as abandoned children have the inherent right to be taken care of by the more fortunate men and woman by means of private community homes or centers where they shall be taught how to free themselves by learning a skill or trade without state or federal interference.
- 8. To protect their property, families etc. from invasion by any unfriendly entity or agency and the right to bear arms without restriction pursuant to the Declaration of Human Rights.

Chapter 2 Form of the ANPC Nation and Self-Governance

Article 1

- (1) ANPC International is a private independent nation organized as a private government with a private members Association being fully bonded, insured and maintaining our own Private Self-Insurance pool for members.
- (2) Self-governance is in the hands of the ANPC members and is implemented according to this Constitution.
- (3) ANPC International is organized based on Natural law.

Chapter 3 The Nation Council, ANPC Assembly and ANPC Juries

Article 1

- (1) The ANPC Nation Council consists of the Office of the Chief of Council who is appointed by general consensus of the ANPC Assembly, being further regulated by the ANPC Juries and Nation rules and by Natural laws.
- (2) The ANPC nation council convenes in a session at least once in every 30 days.
- (3) All decisions of the ANPC Assembly must be agreed upon by a majority vote of the Nation council and can also be regulated by the ANPC Jury decisions.
- (4) IF any one of the ANPC Assembly or Nation council dies, chooses to step down, or violates and dishonors their seat, they shall be removed by majority vote of the Nation council and ANPC Assembly and a new member voted in to replace that seat.

Article 2

- (1) The ANPC Nation council has the authority to amend and enact the Constitution, By Laws, Treaties, Charters or any other documents for ANPC.
- (2) The ANPC Nation council has the authority to add a member to our Nation by written agreement of the new member to be peaceful and lawful with no harm done to another human being and all members agree to take an oath to ANPC.
- (3) The ANPC Nation council has the authority to remove immediately without their consent any member from our Nation with any violation/s to the rules or bylaws set forth.

Chapter 4 The Executive Power

Article I

(1) ANPC International through its Nation council and ANPC assembly, holds the power of government in accordance with Natural Law and this Constitution.

Article 2

- (1) The ANPC Assembly committee is entitled to submit bills to the ANPC Nation council.
- (2) The Nation council may issue By-laws as required in accordance with Natural law.

Article 3

- (1) ANPC has an ANPC Assembly Committee, under the Nation council. This committee consists of heads of the committees of Finance, Family, Travel, Home & Land, Civil/criminal and Embassy/International Relations. Each of these branches shall have a Jury to hear issues relating to their particular committee category.
- (2) This committee will send in quarterly reports and a conference convening reporting all business, old and new to the Nation council.
- (3) The Nation council has the authority to remove immediately without their consent any member from our Nation with any violation/s to this constitution, by laws or Natural Laws.
- (4) IF any member of the Nation council dies, chooses to step down, or violates and dishonors their seat, they may be removed by majority vote of the ANPC Assembly Committee and a new member voted in to replace that seat.

Article 4

(1) Any proposal for the dismissal of a member of the ANPC Nation, may be submitted to the ANPC Assembly Committee. This will then be submitted to the Nation council, which will make the final decision.

Article 5

The ANPC Assembly may not freeze and/or dissolve the ANPC Nation council.

Article 6

- (1) In the event that one of the committee members dies, resigns, is suspended, or is not capable of implementing his/her obligations during his/her term, he/she will be replaced by another member until the end of his /her term.
- (2) In the event that the position of committee member is vacant, the Nation council should hold a session within sixty days at the latest to appoint from two candidates nominated by the Assembly Committee.

(3) In the event that the committee member dies, resign, is suspended, or is permanently incapable of performing their tasks and duties within their term of service simultaneously, the tasks and duties of the member must be undertaken by a joint administration of the numerous sub assembly committees. At the latest thirty days after that, the ANPC Assembly holds a session to appoint a new member from the nominees by the Council of ANPC.

Article 7

(1) Prior to accepting a new member of ANPC, or a committee member, the member must swear or affirm the ANPC oath or make a solemn promise. The oath or promise shall be as follows:

(2) The new members oaths shall have a wet ink autograph and two witnesses---and be turned into the ANPC Assembly for the records.

Article 8

- (1) The Nation council with the approval of the ANPC Assembly Committee may make peace and conclude treaties with other nations and countries globally.
- (2) The Nation council making other international agreements that will produce an extensive and fundamental impact on the lives of the ANPC members and/or that will require an amendment to or the enactment of a by-law, obtains the approval of the ANPC Assembly Committee.
- (3) Further provisions regarding international agreements are to be regulated by Natural law.

Article 9

(1) The Nation council appoints ambassadors and consuls for all global nations.

(2) In the appointment of ambassadors, the Nation council regards the opinion of the ANPC Assembly Committee.

Article 10

- (1) The Nation council may grant clemency and restoration of rights and shall in so doing have regard to the opinion of the ANPC Assembly Committee and the ANPC Juries.
- (2) The Nation council may grant amnesty and the dropping of charges and shall in so doing have regard to the opinion of the ANPC Assembly Committee and ANPC Juries.

Chapter 5 Embassies and Consulates of ANPC

Article 1

- (1) The Embassies and Consulates of ANPC shall be established at locations approved by the Nation council and ANPC Assembly and organized by sub committees under the ANPC Assembly Committee.
- (2) Embassies and Consulates shall fly the ANPC Peace Flag and International Peace Flag.
- (3) All Embassy and Consulate activity and relations shall further be regulated by Natural law.

Chapter 6 ANPC Nation council and Sub Juries.

Article 1

- (1) The ANPC juries possess the authority to hear a case at the first level and come to a fair and just decision in light of Natural law and parallel to this Constitution.
- (2) The ANPC Juries possess the authority to issue a decision over an opinion of the ANPC Assembly Committee with the final decision resting with the Nation council.
- (3) Each ANPC jury is composed of a committee of nine, being of the highest integrity and in full support of Natural Law.
- (4) Each jurror must possess integrity, honor, equity and be in tune with the Constitution and mission of ANPC and shall be prohibited from holding any other position of any foreign government elected or appointed.
- (6) The appointment and dismissal of constitutional jurors and other provisions concerning the ANPC jury is regulated by Natural law.

Article 2

- (1) All ANPC members are equal according to Natural law and governments globally are required to respect Natural law with no exceptions.
- (2) Every ANPC member has the right to work and to earn a livelihood.

Chapter 7 Religion

Article 1

- (1) ANPC is based upon the belief in the One Divine Creator.
- (2) ANPC guarantees all ANPC members the freedom of worship, each according to his/her own religion or belief.
- (3) ANPC has its own ministry known as Vision of Faith Hope & Charity with ministers ordained to carry out ceremonies as needed.

Chapter 8 Freedom of Education

Article 1

- (1) Every ANPC member has the right to receive education according to their choosing.
- (2) Every ANPC member has the right to undertake basic education and teach their own posterity to the best of their ability, and governments globally are required to respect that inherent right to educate their own posterity under Natural law with no exceptions.

Chapter 9 International Flag, Seal, Anthem and Logo

Article 1

The International flag of ANPC primarily Blue, Purple, White with the ANPC seal in the center

Article2

The ANPC Logo is the Peace Dove holding the olive branch.

Article3

The national anthem adopted by ANPC shall be "One Song" by Mitchell Jay Sharof.

Article 4

Further provisions regarding the national flag, Logo and anthem shall be regulated by Natural law.

Chapter 10 Constitutional Amendments


Article 1

(1) A proposal to amend the Articles of this Constitution may be included in the agenda of an ANPC session if it is submitted by at least 1/3 of the total Nation Council.

- (2) Any proposal to amend the Articles of this Constitution must be introduced in writing and must clearly state the articles to be amended and the reasons for the amendment.
- (3) To amend the Articles of this Constitution requires at least 2/3 of the total member Council and ANPC Assembly Committees to be present.
- (4) Provisions relating to the trust form of ANPC International may not be amended.

We, the Nation Council and ANPC Assembly of ANPC International, reserving all our rights endowed by our Creator, hereby do affix our Nation's seal in approval of the attached constitution, subject to further ratification by said ANPC Nation Council in the manner therein provided.
